Occupational Safety and Health and Workplace Disasters. Emma's unique experience in this area allows her to effectively counsel clients on responding to workplace disasters and dealing with and responding to OSHA's involvement in their business operations. She has repeatedly obtained dismissal of citations against clients involved in OSHA proceedings.

Oil and Gas Litigation. Emma has regularly litigated matters arising from oil and gas projects throughout south Texas. She has represented drilling operators, contractors and oilfield services companies in various litigation disputes including contract disputes, royalty disputes and tortious interference claims. Emma has represented numerous companies in lawsuits involving oil and gas-related accidents and employee fatalities.
